

Parental Certification, Consent, and Release

Note: We ask each participant to assume all risks associated with themselves as a condition of their participation.

I warrant that I possess all the rights, powers and privileges of a parent or legal guardian necessary to execute this legal instrument with binding legal effect.

As a parent or legal guardian, I certify and affirm that I have been completely and thoroughly informed that as a kid attending a function or activity of The Dream Center (2301 Bellevue Ave, Los Angeles, CA 90026), Angelus Temple (1100 Glendale Blvd, Los Angeles, CA 90026), Dream Center Discipleship, Lord's Gym, and any of its affiliates, my child will participate in certain activities which carry with them a degree of risk and danger.

Examples of risky and dangerous activities include, but are not limited to:

1. Physical activities, both indoor and outdoors
2. Sports, both informal and organized
3. Use of recreational equipment
4. Field trips, both on and off campus
5. Travel by automobile and/or bus
6. Activities around water, including swimming/boating
7. Hiking and camping
8. Construction and maintenance projects

I acknowledge and understand that The Dream Center, Angelus Temple, Dream Center Discipleship, Lord's Gym, and any of its affiliates may offer other activities. I acknowledge and understand that this PARENTAL CERTIFICATION, CONSENT AND RELEASE has the same force and effect regardless of whether the activities engaged in are free or if a fee is charged.

My child and/or I are a participant and not an employee of The Dream Center, Dream Center Discipleship, Lord's Gym, Angelus Temple, and any of its affiliates.

I am aware of the hazards and risks to my person/ child and property associated with participation in The Dream Center, Dream Center Discipleship, Lord's Gym, Angelus Temple, and any of its affiliates programs. Such hazards and risks including, but not being limited to, death or injury by accident, disease, war, terrorist acts, weather conditions, inadequate medical services and supplies, criminal activity, and random acts of violence. I accept with full awareness of these risks, and, subject to any insurance coverage that may be available to me or my child from any source, and I voluntarily assume all risks of death, injury, and illness associated with such risks, and any damage to my personal property, and I release The Dream Center, Dream Center Discipleship, Lord's Gym, Angelus Temple, and any of its affiliates, and its agents, officers, directors, and employees from any liability whatever arising as a result of death, injury, or illness that I or my child may suffer as a result of participation in the program. I further understand that there may not be any insurance coverage that would apply in the event of a death, illness, injury, or damage to my property, my person or my child that may occur during said participation, and if I desire insurance coverage I am responsible for the cost of such insurance.

In consideration of my child being allowed to participate in these activities, on behalf of my child, I hereby personally assume all risk in connection with said activities, whether foreseen or unforeseen, for any harm, injury, or damage that may befall my child, me, or my family, heirs, assigns, while engaged in such activities, and I still wish to allow my child to proceed with the activities.

I expressly waive any defense to the enforcement of any provision of this commitment arising from a claim of lack of consideration and warrant that this commitment constitutes a legal valid, and binding obligation upon me enforceable against me in accordance with its terms.

I understand that the terms herein are contractual and not mere recital; I have signed this document as my own free act. It is my intention by signing this document to exempt and release The Dream Center, Angelus Temple, Dream Center Discipleship, Lord's Gym, and any of its affiliates from all liability whatsoever for personal injury, property damage or wrongful death caused by negligence.

I further acknowledge and agree that my signature on this PARENTAL CERTIFICATION, CONSENT AND RELEASE shall constitute a bar to any recovery by my child, me, or my family, heirs, or assigns in all suits and actions that may be instituted against The Dream Center, Angelus Temple, Dream Center Discipleship, Lord's Gym, and any of its affiliates, its agents, servants, or employees, or due to the contributory negligence of my child.

I understand that it is my obligation to inform the management of The Dream Center, Angelus Temple, Dream Center Discipleship, Lord's Gym, and any of its affiliates of any and all health considerations or medical conditions that would restrict my child's participation in any and all activities involving The Dream Center, Angelus Temple, Dream Center Discipleship, Lord's Gym, and any of its affiliates or its programs.

In keeping with 1 Corinthians 6:1-8, all disputes, which may arise between any volunteer/participant and The Dream Center, shall be resolved in accordance with the Rules of Procedure for Christian Conciliation, Institute for Christian Conciliation. If efforts to conciliate or mediate the dispute fail, the matter shall be resolved through binding arbitration. The decision of the arbitrators shall be binding on both parties, and both parties submit themselves to the personal jurisdiction of the courts of California, both state and federal, for the entry of a judgment confirming the arbitrator's award. Each party shall bear their own costs, including attorney's fees, related to any mediation, conciliation or arbitration proceeding. If a dispute may result in an award of monetary damages, then use of the liability insurer of conditions, conciliation, mediation, and arbitration procedure on acceptance of the procedure.

I have fully informed myself of the contents of this PARENTAL CERTIFICATION, CONSENT AND RELEASE by reading it before I signed it and I voluntarily sign this RELEASE as my own free act. This is a legal document and I understand that I have the opportunity to consult with an attorney before signing it. I understand that this document covers all events and that I give written or verbal permission for my child to attend any particular event. I expressly agree that this RELEASE is intended to be as broad and inclusive as permitted by law.

CONSENT FOR MEDICAL TREATMENT OF MINOR

I warrant that I possess all the rights, powers and privileges of a parent or legal guardian necessary to execute this document with binding legal effect.

I consent to the examination or treatment of my child by a physician duly licensed to practice medicine in the United States or any health care professional duly licensed to provide health care service in the United States for medical care and services deemed necessary by The Dream Center, Angelus Temple, Dream Center Discipleship, Lord's Gym, and any of its affiliates, its agents, servants, and employees.

I give permission to the Doctor or health care professional to provide any and all medical care they deem, in their professional opinion, to be necessary.

I understand and acknowledge that my permission and consent is sufficient for this purpose. I affirm that law requires no permission or consent from any other person.

I agree to pay for any and all medical expenses incurred as a result of the use of this consent.

I understand that it is my obligation to inform the management of The Dream Center, Angelus Temple, Dream Center Discipleship, Lord's Gym, and any of its affiliates of any and all health considerations or medical conditions that would restrict my child's participation in any and all activities involving The Dream Center, Angelus Temple, Dream Center Discipleship, Lord's Gym, and any of its affiliates.

Should the need for medical attention arise The Dream Center, Angelus Temple, Dream Center Discipleship, Lord's Gym, and any of its affiliates will attempt to contact parents / guardians as soon as practicable under circumstances.
